Tr. Wilson-Hoss: For the Silver Anniversary Committee - Would like publication with history of the Lake Limerick - spotlighting long time active members who have made outstanding contributions.

Bob King stated that the Water Committee should get some recognition too.

The Quorum for today's meeting will be 129 (1288 voting members). George Olson resigned chairmanship as courtesy to the new president.

Correspondence - Thank you from life time social memberships from 3 past presidents. Note saying 'excellent Newsletter" - will pass this on to Ardis Culpepper.

RE: Mason County road widening project - probably won't be this year. Tr. Feist stated that we need to do a lot of work on what we'll go along with, what can be negotiated.

No replacement in sight for the Chef/Inn Manager and we will have to advertise. Ernie will supervise until we get a chef.

Tr. Woodruff reported that citizens Against Crime want to make a presentation after a Wednesday Night dinner for one hour. It was decided that the same information can come from the Sheriff's Department.

MAINTENANCE COMMITTEE - Tr. Frank Pelk

Tr. Pelk reported that a new piston was being replaced in the weed harvester. Time to hire summer golf course help. All greens have been plugged. Working on chipping greens. The hearing, concerning a post employee with the Department of Employment Security, was forfeited because the ex-employee did not call in. Bob King reported that metal plates on end of dock at Log Toy Beach should be removed so no one gets hurt. Also a concrete projection there that should be removed.

LONG RANGE PLANNING - Tr. Al Wilson

Should we invite Ken Engel to address a town meeting on another 9 holes? Question - is he knowledgeable in current development problems, wetlands, etc.? June 16, dinner for Mr. Engel and spouse? Approved.

Concerning the ballfield— Long Range Planning wants to look into improvements when deed clears. Tr. Wilson-Hoss said that D.O.E. has thrown in the towel of the small "wetland" area there. The logging has been completed—all merchantable wood has been sold—rest can be burned. Have to go through shortplatting before he can deed it over. About \$250.00 net from timber that we can use for improvements. Can finish bulldozing. Kimball has dumped stumps there, will trade burning for cat time. Tr. R. Jim Nutt has had four operators working for nothing—what has been spent is for fuel.

EXECUTIVE COMMITTEE - President Patti Gronseth

Tr. Woodruff and Tr. Lombard are working on job description for Chef/Inn Manager. Mary Lou Nault will be Bingo Manager until Fall.

FINANCIAL - Tr. Nan Stricklin

Note: Nan explained financial report handout she has prepared for annual meeting. She reported we're \$29,000.00 better off this year that last. See attached report.

ARCHITECTURAL COMMITTEE - John Stricklin, Chairman

26 applications, including 5 new residences, were submitted. Disapproved applications included an application for a garage 17' from the road, an application for a garage and residence, due to lack of plot plan being submitted. Three problems will be turned over to the attorney for lack of response from previous correspondence.

A Town Meeting will be conducted by the Architectural Committee after the Annual Membership Meeting concerning modular homes.

Russ Myers talked about some way Lake Limerick Country Club could help members who need help.

Motion was made by Tr. Wilson-Hoss, seconded by Tr. Lombard and carried by the Board as follows:

To establish a new committee to be named the Lake Limerick Country Club Support Committee (LLCCSC), to see who needs help. Money would be a line budget item.

Complaints concerning drainage ditch, between Wallace and Gibeau properties, which comes from the golf course was discussed.

The new Maintenance Committee will think hard on this problem. Tr. Pelk will talk to maintenance concerning resolution to this problem.

A letter from Glenn River states that Mr. and Mrs. Peck's home is in fact a modular home, as complying with UBC specifications. Concerning Coleman - deed needs to be returned from Sheriff's sale, will be filed when received.

Tr. Wilson-Hoss reported on tree cutting from the dam area on Club property The application which had been submitted had been denied and maintenance cut trees down anyway. He was very upset with the maintenance supervisor for cutting trees without checking application for approval. Tr. Pelk said he would talk to Howard concerning this. Executive Committee will tell him that when he's in charge there is no room for mistakes.

Norm Schreck is very angry about Trail's house being 2' from his property line. A letter going to Trail's today explaining error was made. We can't make them do anything since it was not their error.

Back to the drain problems - Tr. Pelk said that Howard had provided estimates for pipe (concrete, steel and aluminum) and coarse rock. Rock is the cheapest. George Olson said Garth Anderson very knowledgeable -Tr. Pelk will talk with Howard.

To reimburse Dave Best for stocking lake Leprechaun with fish.

Motion was made by Tr. Feist, seconded by Tr. Pelk and carried by the Board as follows:

To have the Lake/Dam Committee budget stocking Lake Leprechaun with fish.

Bob King reported on the algae study. Because of severe algae bloom this year water samples were taken. D.O.E. said 45 to 60 days to get permit. He reported that the permit process was quite involved. A licensed applicator is needed. Allied Chemical could do it at approximately \$20.00 per acre plus \$50.00 per hour. The cost for Lake Limerick Country Club to do the work would be prohibitive. Mr. King stated that there was a group from a state water quality agency, a citizens monitoring group, who has a monitoring program at no charge.

Motion was made by Tr. Lombard, seconded by Tr. Wilson-Hoss and carried by the Board as follows:

To encourage the Lake/Dam Committee to go with the water quality group to monitor the condition of the Lake.

Motion was made by Tr. Wilson-Hoss, seconded by Tr. Pelk and carried by the Board as follows:

To authorize Bob King up to \$750.00 for algae treatment, along with a specification letter from Allied Chemical.

Motion was made by Tr. Wilson-Hoss, seconded by Tr. Lombard and carried by the Board as follows:

The Board, for this purpose only, allow this application, concerning the Board of Trustees motion of June 17, 1989.

Mr. King reported on the F.D.S. project. Construction on Cranberry Lake has been done as expected. The log boom will need to be moved to get a good look at the bio-muck build up. Curtis Bennett, Kimball Construction, wants to complete project as soon as possible, including clean up. The dam work is being done as expected. About 1000 yards of fill will be needed. Any extra fill needed will be under contract. Project should be completed within the month.

President Gronseth thanked Mr. King for his work on reporting the ${\sf F.D.S.}$ progress.
