To include the following issue on the ballot, "Shall the Board of Trustees be authorized to meet the State of Washington Fuel Storage Guidelines at a cost not to exceed \$11,000.00? There will be no per lot special assessment required."

The above will be included in the March/April Newsletter.

Jim "R" Nutt will also give an update on hazardous waste material. The office will check with our insurance company.

WATER COMMITTEE: Dave Best reported on the minutes. Dave reiterated that the four possible reservoir sites are only at the preliminary testing stage. The Engineer's recommendations will be brought to the Board of Trustees for final approval. The fish ordered for Lake Leprechaun will be here next week.

GREENS COMMITTEE: Carl Neilsen discussed the minutes. He noted that \$2,000.00 had been spend on drainage of the \$4,000.00 budget and would like to have a budget adjustment and shift the funds to the cart paths. They have an estimate of \$1,900.00 to black top designated areas. Jim "R" Nutt will look at the discussed paths.

Max and Betty Dean, the new Marshals will be given the club policies and a letter of compliance to sign. Dick Lombard will also write them a thank-you.
