### **BOARD OF TRUSTEES March 20,1999**

#### **ROLL CALL: Dick Lombard**

President Dick Lombard called the meeting to order at 9:00 a.m. Trustees attending the meeting are Vice President Nan Stricklin, Treasurer Bill Buff, Trustee Ruby Bailey, Trustee George Buckley, Trustee Pat Paradise, and Trustee Scott Carey.

Trustees absent are Secretary Esther Springer-Johannesen, Trustee John Bykonen, Trustee Darrell Winans, and Trustee Doyle Wilcox.

#### **APPROVAL OF MINUTES:**

Motion made by Tr. Bill Buff, seconded by Tr. Ruby Bailey, and carried by the Board as follows:

The Board of Trustees approves the minutes of the February 20, 1999, board meeting with the following corrections: Page 2, Motion regarding Lake/Dam Committee, change Ski Course amount from \$2,050.00 to \$2,500.00.

#### **FINANCIAL REPORT: Bill Buff**

Treasurer Bill Buff presented the February Income & Expense reports. He reviewed the five-month income statements and the budget comparisons by department. It is a nice picture for the five months. The restaurant members' food sales have increased 99% compared to last year.

Motion made by Tr. Scott Carey, seconded by Tr. George Buckley, and carried by the Board as follows:

The Board of Trustees approves the February 1999 financial report as presented.

One of the office computers was damaged during a power outage, and a replacement was purchased. During installation the computer engineer lost all of the data he was supposed to transfer between the old computer and the new computer. Capital Business credited LLCC with \$1,053.00 and repaired the old computer. Since most of the data had been backed up on tapes and discs, none of the LLCC accounts were affected, only the Microsoft Word and Excel data. Bill purchased a scanner to duplicate the lost reports. The net cost to LLCC was \$397.43.

### Consent Agenda, Item 1. Inn – Drink Prices

President Dick Lombard said the call drink prices are set at the discretion of the bartender because the liquor prices vary.

### Consent Agenda Item 2. Greens Committee –

Freens Chairperson Scott Carey reported 46 annuals had been purchased as of March 18, 1999. The golf annual sees were due March 1<sup>st</sup>, or the golfers had to pay the daily fee rate.

#### **OLD BUSINESS**

### 1. Water Committee - Meter Status Report

Water Secretary Henry Yates reported the meter installation is ahead of schedule. The scheduled completion date is September 1999. The meters will be read in the year 2001, this gives the water committee time to address any problems.

### 2. Lake Leprechaun - Status Report

Maintenance Supervisor Dave Chestnut discussed three projects. The projects are: 1) Clean up of lower Cranberry Creek stream banks 2) repair and maintenance of an existing fish ladder at Lake Limerick and 3) repair and maintenance of Lake Leprechaun's spillway. He has received the permit from Dept of Community Development (Mason Environmental Permit). The State will also be sending a permit authorizing completion of the projects. These permits are written to cover a five-year period. He has worked with Mason County Dept of Community Development, the WA State Dept. of Fish and Wildlife, and the fisheries biologist for the Squaxin Tribe in designing the project.

#### 3. Candidates Night - Report

Nominating Committee Chairperson George Buckley noted the March 12, 1999 Candidates Night dinner went well. All but two candidates attended, the other two were out of town. George recommends early Candidates Night dinner again next year, before the absentee ballots are mailed on March 15<sup>th</sup>. The office had received 61 absentee ballots as of yesterday.

# NEW BUSINESS: None EXECUTIVE:

#### 1. Custodial Contract Recommendation

Our current janitorial contract is scheduled to be renewed in April. The expenses are averaging \$847.00 per nonth. The committee considered hiring an employee to work 4 hours a day and he/she would report to the maintenance supervisor. The job description will be developed by April 1st.

Motion made by Tr. Pat Paradise, seconded by Tr. Bill Buff, and carried by the Board as follows:

The Board of Trustees approves the recommendation from the Executive Committee not to renew the Jora Lee Cleaning Contract in April, and hire a part time maintenance/custodial employee to clean the building. The Maintenance Supervisor will be responsible for the job description and employee's supervision.

Help wanted ads will be posted in the paper. Dave Chestnut will interview the applicants.

### 2. Contract Davis Wright, Tremaine, - VP Nan Stricklin

Davis, Wright, Tremaine, Attorney's at Law represent Lake Limerick in a past employee law suit. President Dick Lombard has asked Vice President Nan Stricklin to act as the contact person for Lake Limerick. This was requested by President Lombard to avoid any appearance of a conflict of interest.
