If Lake Limerick is in a "Not for profit" status. And members are required to put their name and lot number on the check presented to them for payment, why are we charged Sales Tax?? It would seem that the reason for putting member information on the check is to avoid payment to the Department of Revenue for members use. This information then would support your reporting procedure in the event of an audit.
