I. ROLL CALL:

II. GUESTS FROM THE FLOOR: (additions to the agenda)

III. APPROVAL OF MINUTES:

A motion was made by Dick Sirokman seconded by Tom Taylor and passed with no nays as follows: To accept the minutes of July 2007.

IV. FINANCIAL REPORT: Esther Springer-Johannesen Treasurer

Discussion of budget allocations and how to determine what is available for what. The current maintenance budget covers part of the green committee and Lake/Dam parks committee needs, and there is some communication confusion of available budget. It was decided that the committees need to go over this with Jerry Thompson. Also noted; there is going to be a drop in budgeted revenue, do to the sprinkle system, and this needs to be pointed out to the members.

Esther is still getting numbers from the committees, for the capital expense, will have figures to discuss at the next executive meeting.

V. CONSENT AGENDA: (Committees motions)

The water chair was congratulated on the payment agreement, policy and procedures and the termination notice. These are all needed policy formats that needed to be done.

A motion was made by Dave Kohler seconded by Esther Springer Johannesen and passed with no nays as follows:

To consent agenda, the following exceptions: Although not a motion the board felt that the question of screens should be revisited, along with researching the temperature settings for the restaurant and lounge. The question was that 75 degrees for the air conditioner was too high. Suggested was that the temperature be set at 72 and if it needed to be turned up Dale could do so. The solution of screens in the restaurant raised questions of cigarette smoke coming in to the restaurant, also opening the doors created health hazards, with flies in the bar.

VI. OLD BUSINESS:

- 1. 2010 Project: Chris Johannesen created a map of who has signed and who has not; many members have put it aside, or forgotten. The desire is to get the required signatures and go on to new projects.
- 2. Signs: New signs have been put up for Olde Lyme Park. The old reader board was falling down, so it was removed. The board is getting estimates for electronic and/or replacement.
- 3. Dump waiter: Will be put back on the capital budget, the estimates were higher then anticipated, so the board has pushed the project back.

VII. NEW BUSINESS:

- 1. Geese: There have been member feeding the geese, then washing the waste back into the lake. Feeding the geese is not allowed. A letter has been composed and the members will be notified.
- 2. Pro Shop: D.J. the pro quit, and the board has appointed Gail Gagner to run the golf shop & tournament to the end of the season. The board doesn't think there is a budget to carry a pro year round. Income is down due to weather this year and the board has asked wages to be cut
- 3. Inn: Again wages are too high and the board has asked them to be cut.
- 4. Lake/Dam requested that the board give the park host a free dinner in appreciation of jobs well done. Gift certificates were approved.
