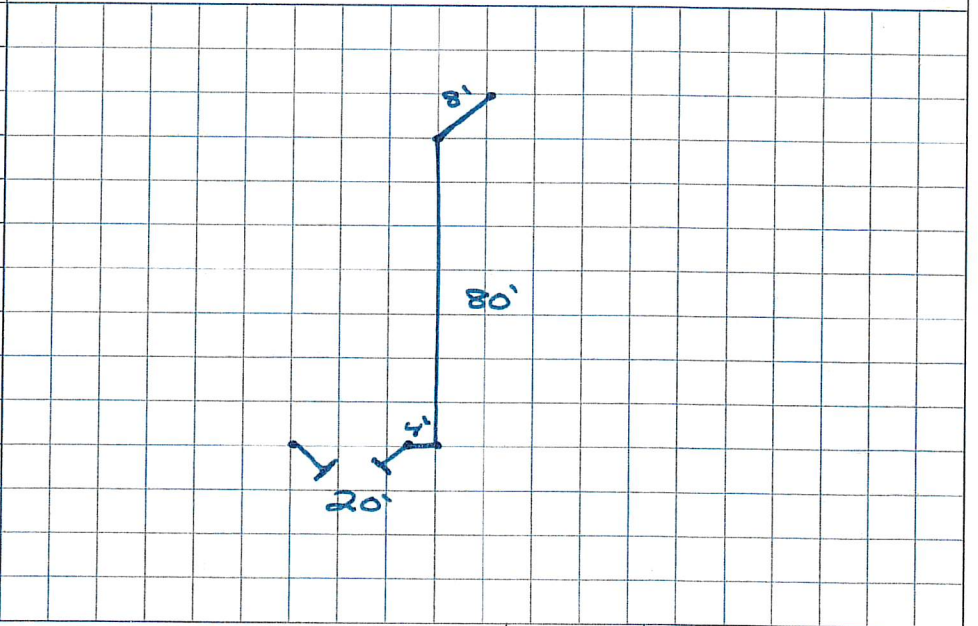

1) Any work or materials delivered or installed in addition to that proposed in this estimate shall be subject to an additional charge and will be billed at the current rate. Summit Fence Co. is to be held harmless and Customer shall indemnify Summit Fence Co. for any and all claims, losses, or damages that arise out of construction of this fence; provided however, the loss, claim, or damage is not caused by the sole negligence of Summit Fence Co.; provided further, if the loss, claim, or damage is caused by the concurrent negligence of both parties, Customer will indemnify Summit Fence Co. to the extent of Customer's negligence. 2) Customer shall have sole responsibility for determining whether any codes or other government regulations apply with respect to the project under this contract and shall be solely responsible for obtaining any and all necessary permits. Customer shall also be solely responsible for verifying property lines. 3) Summit Fence Co. will assume the responsibility for calling LOCATES, Inc. to locate and mark underground public utilities. However, Summit Fence Co. assumes no liability for sprinkler lines, or any buried lines or objects. Customer will assume all liability for all damage caused to property, persons, or animals by directing Summit Fence Co. to erect this fence. 4) If an account is overdue after five (5) days the Customer agrees to pay a delinquency charge of 5% per month on the unpaid balance and an additional surcharge of 25% of account balance plus reasonable attorneys/collection fees if an account is referred to an attorney or collection agency for collection. 5) The parties further agree that in addition to any other rights Summit Fence Co. has, and without prejudice to the same, that Summit Fence Co. may claim a lien on the materials and supplies that have been installed, either in whole or part and on the premises that the materials and supplies have been installed on, and that Customer waives notice of same. All materials remain the property of Summit Fence Co. until all invoices pertaining to this job are paid in full. Right of access and removal is granted to Summit Fence Co. during the construction of the fence and in the event of non payment under the terms of this contract. 6) This contract shall be considered to have been made in and shall be interpreted under the laws of the State of Washington. The site of any arbitration or venue of any lawsuit arising out of the contract or the work hereunder shall be in Thurston County, Washington.
