Moved by Mary Ann and seconded by Sue to accept the April and May minutes. Motion passed with no nays.

1. "Beautifying" the Ballantrae entrance- update

A request was made to this committee by Pat Jankord and others to present to the BOD a project to improve the appearance of the area around the Ballantrae entrance sign. This would make it look more like the main entrance sign area. They have presented a plan and if accepted by the BOD the volunteer group would do the work to complete the project. They would be asking LLCC to reimburse them for 90 garden stones (\$500) and 2 yards of topsoil (\$60). A PAR will be filled out.

2. Trails update

a. Maps for members to use for walks around the community on low traffic roads and existing trails are ready. With the approval of the BOD the Greenbelt Committee would like them made available in the Office, Pro-shop, Welcome Packs and they can be put online so they can be downloaded onto phones and computers.

b. It was pointed out that the trail from Dunoon to St. Andrews is not well marked on the Dunoon side. It looks like someone's driveway not a trail. There was a discussion about different ways of possibly marking the trail so that those who have never taken this trail know how to find it.

3. Litter pick-up

The next litter pick-up event is scheduled for Saturday June 24th. Participants to meet in the Inn parking lot at 9:00 AM. Advertising of the event still needs to be done.

4. Dog Park update

Still working on the dog park. Having a hard time connecting with a Lake Limerick member who works in construction and has done other projects for LL. Want to have him check out the plans for the park to see if he has any suggestions.

Dean has checked out the dog park at Alderbrook. It has a 4-foot fence. It is well used according to a resident and the users do a very good job cleaning up after their dogs. Dean walked through the dog park and found no poop. A nice surprise.

5. Planting new trees in greenbelt on Mason Lake Road

This project is ongoing and will be planned for the fall because the newly planted trees would become established better in a season with more rain. The fine for cutting down the trees has been paid so the money for this project is already available.

6. Wildfire Readiness

Dean has called the Wildfire Ready Neighbors program about having a townhall meeting for the community but is still waiting for a return call. Sue mentioned that it may be best to call Mason Conservation District to arrange this. Dean will do this next week.

7. Counting Salmon

Sue pointed out that the members still do not have an internet place to go to view the salmon count into the lake when they are coming into the lake in the fall. Dean will talk to Christy about this.


8. Budget
