Cart Path Paving Project

The contract with Pave-X, LLC to pave the cart paths with asphalt was approved by the Board of Directors in an electronic vote on Thursday, August 3rd. Because of a directive from the Navy stating that no work should be done on their property, the board voted to proceed with the project and exclude any of the paths on Navy property. The amount of the contract is \$111, 334.02. Funding for this project is from the golf special assessment approved by the community. Jason Howerton, Greens Superintendent, is the project manager. Greens Committee Chair Vern Duggan, Golf Pro Ron Stull, CAM Deborah Wallace, Jason, and BOD President Kelly Evans negotiated the contract with Pave-X on August 2nd. Paving is planned to begin August 28th and should take about four days. The golf course will be closed while this work is being completed and is expected to re-open for Labor Day weekend.
