The Board has been reviewing the list of additional capital projects submitted by committees and staff last fall as part of the annual budget process. Once reviewed and prioritized, the Board will approve the top projects for implementation work to begin in anticipation of our upcoming busy, summer season.

COMMUNITY ASSOCIATION MANAGER- Deborah Wallace

Every September a budget is created to map out the expenditures for the year. This is a great tool to measure the fiscal performance of the association. The Board and the management team want to make sure that your monies are being responsibly managed and spent to benefit the entire community. Each month we report the actual amount spent versus what has been budgeted. All financial reports are available to members at any time. The monthly profit and loss statement is posted in the office and is also available at every Board meeting. I am happy to say that the organization is in excellent fiscal health and being monitored daily. Should you wish to discuss any financial matters, I am happy to assist you.

If you have concerns with your billing, Rhonda Hunt can help you with complex issues, payment plans and water billing questions. Leedia, Christy and Terry can take your monthly payments and assist with simple matters regarding your HOA and Water accounts. We are very excited to offer a new way to effortlessly pay your HOA bill with a recurring payment authorization form that lets us bill your credit or debit card every month. Come into the office and fill the form out and you will never have to worry about remembering to make a payment!

Leedia Bailey, our member services point person, can answer any questions about park passes, boat registrations, hall rental and other member concerns. She does a fabulous job on our communications making sure that the latest news and information is posted to the website and sent out in email blasts. Please contact Leedia if you would like to have your name added to the email mailing list as it's a great way to get information from Lake Limerick.

Every accounting department needs an experienced and versatile professional like Terry Hinchcliff. There is very little that she can't handle. She makes sure our bills are paid on time, and that all monies are properly posted and accounted for. She is an asset to the smooth running of the office, and she is also available for member questions and concerns.

Our job is to provide financial integrity with transparency and honesty in all transactions. Lake Limerick is lucky to have such a devoted and caring administrative team that has the best interests of the members at heart.

WATER COMMITTEE--Don Bird, Chairperson

<u>Water Quality:</u> The water quality of our system continues to be excellent. We recently did required testing for lead and copper at 10 residences. The amount of lead in all samples was too small to be measurable. This isn't surprising because there are no lead pipes used in our water system. In about half the samples copper was undetectable and in the other half the amount was very small and was less than 1/10th of the State regulated limit. The amount of copper is dependent on the type of water pipes used in a house.

<u>Backflow Prevention Assembly Testing:</u> Every three years we are required to test, and repair if necessary, all the nearly 800 backflow prevention assemblies installed at Lake Limerick. These devices are installed between the main service lines and each meter box to prevent contamination of the water system. In April we will have a specialized testing company perform this work. While they perform the test on the device servicing your house, your water will be interrupted for a few minutes. Notifications will be posted to let you know when testing will be done in your neighborhood.

<u>Water Billing Statement:</u> In September 2017 the water bill format was changed to plain paper bills to save money. The new full-page format will allow us to provide you with more information. We are exploring options within the billing program to provide a breakdown of the various charges. Don't be surprised if in the next month or so you see a different format for the bill.

<u>Water Filling Station:</u> A "water filling station" has been installed next to the Well #2 building adjacent to the putting green. Any water truck that is authorized to draw water from our Water System will be required to use that station. This will allow us to meter the actual amount of water used each time and also monitor for any unauthorized use. The Fire Department will continue to draw from hydrants around the lake to test the hydrants. Now that the "water filling station" is available, any other unauthorized water use from Lake Limerick hydrants should be reported to the Water Department or to the Sheriff.

<u>Water Conservation:</u> Unaccounted water losses for the last month were less than 5% which is better than our average loss per month last year. However, please continue to watch for leaks on your property and other areas as you walk around the Lake.

LAKE LIMERICK STREET SIGNS—Brian Smith, Secretary

At its February meeting, the Board approved a recommendation to replace the old wooden street signs with signs provided and maintained by Mason County. This idea was first proposed a few years ago but rejected by the then Board. Since then, member volunteers and staff have tried to maintain the existing signs. The signs are dilapidated, poorly placed, falling down and hard to see and read. The Board decided that going with Mason County installed and maintained signs would 1) let members find streets more easily, 2) let visitors find streets more easily, 3) forego a \$1,000/year maintenance cost for Lake Limerick, 4) let first responders find streets more easily, and 5) provide attractive, uniform and durable signs improving the appearance of the community. One member of the community at the meeting suggested selling the old signs to members interested in owning a bit of Lake Limerick history.

GREENS COMMITTEE- Vern Duggan, Chairperson

Hello from the Greens Committee. I hope everyone is in good health. Spring is right around the corner and we are looking forward to a great season.

We have seen more play on the course this winter due to an aggressive sanding program on our fairways. The conditions have been better this year and will continue to get better in the future. We have reduced the cost of sanding by 1/2 because of better pricing that Jason Howerton negotiated from the sanding company. This is one example of how we are being good stewards of our money.

There has been an increase in walkers, with and without their dogs. We are glad to see people enjoying the new golf pathways. There are a couple of reminders in that regard. The dogs need to be on a leash and what your dog leaves behind, needs to be picked up by the owner and deposited back at your home. Walkers must be aware of the golfers because they have the right away. Golfers are always looking out for the walkers. We do not anyone to get hurt.

A reminder that skateboard and bicycles are not allowed on the cart paths.

We now have a new set of tees (black). They are shorter in distance. This will help newer players come out and not be so intimidated by the length of the course. This winter we have had two tournaments, playing off the black tees and 40 plus players played in the tournaments. At the time of the tournaments, Brandon offered a food special, at the Café' (it was delicious) and most golfers did partake. This was an increase in revenue during the winter months.

Last year the golf course raised over \$220,000... Our expectations for the coming year are to increase the revenue and keep costs down. Our Golf course Maintenance crew not only work on the golf course but work at our PARKS, INN, LAKES AND DAM. They do a great job for us. This way, the Lake Limerick assets are maintained.

The Greens Committee hopes that there are more members who come out and enjoy Lake Limerick's golf course. This is our asset and it belongs to all of us. We are continuing to look at ways to keep costs down and to increase revenue. We have great Assets and they need to be maintained and improved.

ATTENTION FISHERMEN;

We are starting our planning for the 2018 LLCC fishing derby. This year, the derby will be on April 28th and, as in past years, there will be; 1) cash prizes for biggest fish 2) cash prizes for tagged fish 3) special door prizes (second chance) and 4) a raffle drawing for prizes donated by both local businesses and our community members. Tickets will go on sale in March. Docks

Numbering your docks is mandatory. Steve Glenn, a member of the Lake Dam Committee is making dock placards with reflective lettering. They are 4" x 10" aluminum plates that your division and lot number can be placed on, then attached to your dock with screws. The cost to you will be \$10 and the plates will be available to order in the office. The Dock Sign purchase request form is available on the Limerick website under Association>Association Documents. If you are concerned that you might have difficulties with the

attachment part of the process, come to a committee meeting and ask for help. There's a group of handsome handy guys, that if you offer a plate of cookies, may be more than willing to help a neighbor out.

If your dock is still floating on white or blue encased Styrofoam - replace the floats. If your dock is in poor condition - repair or replace it. These duties are requirements not requests.

Dam Weir Boards

LLCC staff will begin placing weir boards into the Lake Limerick and Lake Leprechaun dam structures in April. The weir boards provide higher lake levels in the summer and help maintain flow in the Cranberry Creek watershed. You should notice water levels rising throughout April, especially in Lake Leprechaun before the fishing derby fish are planted in both lakes.

Weed Control

We're scheduled to have both lakes treated with aquatic herbicides for weed control between July 15th, and July 31st this summer. Our contractor will post advisory signs identifying water use restrictions prior to treatment. Herbicide treatment is regulated under a permit issued by the Washington State Department of Ecology. During the short treatment periods, follow the directions on the notices regarding withdrawing lake water for potable, domestic animal, livestock, or irrigation purposes. LLCC makes every effort to treat weeds as required, in an environmentally safe and healthy manner.

If you see weeds in the lake - pull and remove them. If you use fertilizers for your landscape - make sure they're phosphate and nitrate free. If you drain hot tubs, kiddie pools etc. do it in such a way that they don't drain directly into the lake. If you wash cars, boats or outside gear - do it as far from the lake as possible. If you see a duck – make it move off your property. If you're tired of the bio-muck in shallow areas – come talk to the lake dam committee for ideas as to what you can do.

Boating Season Approaches – Safe and Sane

If you acquired a new (or new to you) power or pontoon boat 16 feet or longer powered by a motor of 10 HP or greater - register it at the office before you put it in the water. When you come to the office you must bring with you a current original Washington State boat registration that shows the length of the boat, and that a member is the owner of record.

"It's a fact universally acknowledged that" . . . a group of people believe the **RULES** do not apply to them. There are a group of people who believe they know the **RULES** inside and out – and have subsequently forgotten most of what they knew or failed to notice **RULES** changes. The **RULES** are there with the hope that by following them, we reduce the chance of accidents, especially the catastrophic type. So, please read the **RULES** again. Even if you don't go near the lake. Review them with guests and family. Report people who do not follow the **RULES**. The key to safety on a small and busy lake is to be able to predict what other people are going to do. Let's be predictable!

The <u>Lake Restrictions and Regulations</u>, <u>Dock and Float Guidelines</u> and <u>Vessel Registration</u>

USGA Rules of Golf

I have written about the new rules starting in 2019. They are posted on the bulletin boards in the "If Ida Room". If you would like a copy, please check with the Pro Shop. I will be sending out this in the *Limerick Times* newsletter in August.

This past year we have tried to make "playing by the rules" an important part of playing golf at Lake Limerick. We will continue this. If you have questions about the rules, please feel free to ask me what the proper procedure or implementation should be. Prior to the 2019 season changes I will be holding some seminars to go over the new rules. They are both fairer and simpler. I know everyone will look at them and say ... "what took so long to change them".

Golf Tip of the Month

The biggest factor in obtaining a lower handicap is distance. The longer you can hit it the lower your potential handicap can be. Hitting it straight and a great short game can really help, but longer is better. Okay, so how do you hit it longer? Well, it certainly isn't swinging slower! To gain more club head speed, practice swinging a fast as you can. If you have a short backswing, lengthen it. If you don't have a wrist cock, create one. Each mile per hour is worth 3.5 yards in distance. If you hit the driver 3 degrees more offline than normal, you probably are still in the fairway.
