

DECLARATION OF COVENANT


This Declaration of Covenant is made by LAKE LIMERICK COUNTRY CLUB, INC., a Washington Not-for-Profit corporation, in favor of the State of Washington, Department of Social and Health Services, and pursuant to W.A.C. 248-54-125. LAKE LIMERICK COUNTRY CLUB, INC., hereby declares a Restriction on the use of the following-described land, of which it is the legal equitable owner and possessor, as follows:

Restriction:

No source of contamination as defined in W.A.C. ch. 248-54 or its successor(s) may be constructed, stored, disposed of, or applied on the following real property without the permission of the Department of Social and Health Services and LAKE LIMERICK COUNTRY CLUB, INC.; and said restriction shall run with the following real property, and be an encumbrance thereupon for so long as public drinking water is withdrawn from within the pollution-free zone:

A 100' radius circle the center of which is described as follows: Beginning at the Southeast corner of Lot 137 of the Plat of Lake Limerick Division Two as recorded in Volume 6 of Plats at page 75 Records of Mason County, Washington; Thence N 0° 31' 18" E along the East line of said Lot 137, 175.00 feet to its Northeast corner; Thence S 89° 23' 02" E, 110.20 feet to the center of said circle.
