**Minutes:** February minutes were reviewed and a motion was made by Gayle Wilcox to approve the minutes with a second by Mary Lou Trautmann. Passed

**Greens Report:** Grass is growing due to nice weather so crew has been out mowing and cleaning up storm debris. Early Spring fertilizing will be taking place. Repair to cart path along hole # 3 will be taking place to fill holes and make it safer for carts. Annual deep drilling will take place on March 30<sup>th</sup>. Discussion on finishing the cart part took place. Jason has received two quotes on moving cart path off Navy land on hole #3 have come in between \$11 and \$16,000.
