Meeting Minutes

Call Meeting to Order- The meeting was called to order at 6:30PM by S. Stoney - Chairperson

Attendance: S. Bird, S. Klemp, T. Ingwaldson, J. Ingemi and S. Stoney

Approval of Minutes:

S. Bird made a motion, and it was seconded by S. Klemp to accept the minutes as presented. Motion passed unanimously.

Old Business:

New Business:

S. Stoney brought up the new “New Member” packets. She has been working with Christy on what should be in them and there were numerous discussions on who should get them and how.

- a. While the packets are going to be specifically designed for new members, S. Stoney stated that they will also contain information / updated information, that would be beneficial for all members of the Community. After some discussion, it was generally agreed by the Committee that this would be a good idea to send to all members of the Community.
- b. The packets would contain a lot of information on Committees, events, helpful information on who to contact in case of problems (water, fire, etc.). They would contain golf and dinner vouchers, a new member card(s), calendar, newsletter(s), vehicle sticker, a lanyard, etc. Maybe a map of the Community? There was discussion and some confusion on whether the new member card would also double as a key card for Anglia Park. S. Stoney will verify this information with Christy. T. Ingwaldson floated the idea that maybe Central Mason Fire Dept. might want to donate some smoke detector batteries? Something to look into.
- c. There was some discussion around distribution of the packets. As they are currently set up, they would be expensive to mail. For current members there were suggestions that we set up a canopy at our various parks, on different days but the same time of day, and give them out (I.D.

required and would be included in a notice.) There was some concern expressed about the logistics of such an event. Also, since current members are only receiving new member cards, car decals and lanyards, the idea of these being distributed via the water/dues bills might be feasible. For “New” members, our Committee will still deliver them in person. When would all of the items be available for the packets to be assembled? Do we have everything in house already? While we are getting closer to having this organized, there was still some concern about “in-person” handing out of the packets (masks, social distancing, etc.) We will continue to explore our options. S. Stoney wants to set something up to go over packet assembly. She will be available after the 18th of this month. S. Bird would like to start to assemble the packets as soon as possible, to have them ready for however we decide to distribute them.

Some other issues discussed were: a voucher for the Café, for a 2 for 1 from Dale (in order to give members an introduction to these amenities); are lanyards necessary and will members actually use them? S. Klemp asked if we have a budget for these items? And again, could some things (like the new membership cards) be mailed with the dues/water bills?
