- Received 8/4/2024 | 03-047 | **shed** reviewed during Arch Meeting 8 x 16 Portable shed 96' from lake 6' from side of property all information provided, setbacks met. APPROVED.
- Received 8/9/2024 | 05-002 | fence owners came to Arch Meeting to provide information and get feedback on their permit application. All setbacks met, information provided – APPROVED.

## Discussion:

- 01-098 owner is planning on putting in a new cement "square" in front of their door/porch to cover the gravel/bark. Considered landscaping, no permit needed.
- 04-138/139 owner had been sent a fine for fencing that had been put on property. Fence on the
  back may not be compliant with setbacks to Cranberry Creek. Fence had been built before new
  owner had signed papers to the property. They should work with Department of Ecology to
  ensure compliance or variance on fencing.
