Trails update: Pathway for safety follow-up: Location St. Andrews Dr.

*Requested Survey for improvement along St. Andrews Dr. *Oct. 2024 BOD meeting approved survey to ask community about pathway along St. Andrews. The BOD feels a need for clearer information from the county about how this project will be paid for and any costs to LL residents, including assessments and future tax increases.

*Dean has reached out to request a TIP-CAP representative attend a recorded committee Town Hall meeting, date to be announced. This committee will notify the members along St. Andrews and the community once a date has been decided.

*Also, during this discussion it was noted that the speed limit along Mason Lake Rd, within LLCC's entrances are not all at 35mph. This committee will also recommend to the County to take a look at this for an update to the speed limits.

Litter Pick-up

*Litter pick-up date is Monday, January 20, 2025 meeting time 9am-11:30am gathering outside the Café to sign-up, complete waivers if not already done previously, gather trash bags, safety hat & vest and trash grabbers.

*Also, during the litter pick-up discussion, Sue K. suggested that we consider a review of lots and other area roadways that are collecting trash in order for our committee to lend a hand in cleaning up the areas within our community. We will alert the Compliance Committee of lots needing clean-up and discuss the best way to handle this clean-up (committee involvement or not) and focus on roadways that could use help during our litter pick-up days.

Emergency Management Sub-Committee:

*It is suggested that anyone interested in Emergency Management attend CERT TRAINING. *Mason County is actively recruiting community volunteers to attend a 20 hr. CERT TRAINING class. Course topics include basic medical operations, light search and rescue, small fire suppression, team organization, emergency preparedness, hazard awareness, and other topics that community volunteers, can use
